Barton House – Thursday 30 November 2023 update

Here are the latest updates for Barton House residents, including details about our arrangements to reserve rooms at the Holiday Inn for the foreseeable future.

Update on our arrangements with the Holiday Inn: I understand that the current circumstances are difficult, and some have expressed uncertainty about what arrangements are in place for accommodation whilst the structure of Barton House continues to be examined. I want to assure you that arrangements have been put in place to secure enough rooms at the Holiday Inn for the foreseeable future with a contract now signed to hold the rooms until the end of January, should we need them. This is a precautionary arrangement in case the space is needed and not linked to any decisions about the future of Barton House. The surveys we need to carry out are ongoing and once we have the results, we will be able to tell you more clearly what the next steps are for the block.

The agreement with the Holiday Inn is detailed in a report due to be considered by the city's Cabinet at their meeting next week (Tuesday 5 December). In the report, you will see we have put aside the money needed to secure the rooms as long as we need them and continues to include all meals, laundry and the transport arrangements for all residents displaced by the evacuation.

We are having regular meetings with the hotel to discuss feedback from residents, and to make sure we are responding to residents' feedback as soon as possible.

Food menu: Following your feedback, from today the Holiday Inn will share a meal plan for lunch and dinner, which will start from next week (Monday 4 December). This is so you have advanced notice of the food served at the hotel every day. If you have further feedback on the food served, please contact hotel management to let them know.

Food temperature: Thank you to residents who raised concerns that that food served in the Holiday Inn restaurant has sometimes been served without lids. We have raised this with the hotel to remind them to make sure food is kept as warm as possible. Hotel management has confirmed to us that food warming containers will be pre-heated in advance and lids will always be used from today onwards.

Temporary accommodation: We are aware of rumours about the security of people's tenancies at Barton House if they accept alternative temporary accommodation while the building is evacuated. These rumours are untrue, and we can assure you that your tenancy at Barton House is secure, regardless of what temporary accommodation you are in now, or if you move. A few residents who need it based on their circumstances are to be offered alternative temporary accommodation which is not in the Holiday Inn. We make these decisions based on the individual needs of these families – including considering the additional living needs and accessibility of their accommodation. We want to be clear that any tenants who accept temporary accommodation, of any kind, **will not** lose their Barton House tenancy.

Nappy disposal: The Holiday Inn are going to make additional larger nappy bins available on each floor very soon. When we are able to confirm when these will be ready, we will let you know as soon as possible.

Staying at Holiday Inn: Please remember that visitors and other guests are present at the Holiday Inn. Children and young people must be supervised if they're outside of their rooms. Please be mindful of fellow residents and Holiday Inn guests and keep noise to a minimum. If you have any issues, please speak to the Holiday Inn staff.

Activities update: We have updated our activities list. For a print-out of these activities in English, or other languages, please ask your Housing Officer. You can also look at the activities list online at bristol.gov.uk/barton-house.
