Second Floor Flat, 47 South Parade Mansions, Oakfield Road. Internal alterations. 24/00717/LA

St Annes Infant School, Bloomfield Road, Brislington. Works aim to provide a SEND Base for St Annes Infant School as well as a SEND Provision for 24 pupils. Refurbishment to the single storey building. Work involves extensive redecoration & making good of the walls, ceilings, floors & existing sanitary facilities, creating staff facilities and 2 toilet cubicles. The work also extends to sympathetically upgrading the play area boundaries & ground treatment to make the areas safe for the children. The external improvement include new timber fencing around the SEND play areas with gates on access control system, new CCTV & intercom access control system to the pedestrian gate & surface materials to the play areas. The proposal includes creating a opening in a part of the building that is not original. This will create a better defined & accessible entrance for the SEND Base. 24/01085/LA

Replacement windows, PV panels located on the SW & NE facade of the roof pitch, & air source heat pump located to the rear garden level. glazed doors to the rear external facade, including the addition of a rear balcony & a loft level juliet balcony. New rooflights located in position of bespoke rooflights on northern pitch. 24/01372/H
