Privacy Notice - Retrofit Pilot Project

Bristol City Council is the data controller for the purposes of the Data Protection Act 2018 and other regulations including the UK General Data Protection Regulation (UK GDPR), which means it determines what your personal data is used for and why it is collected.

The purpose of this privacy notice is to tell you about how we collect and use personal data in connection with our service. We may update this privacy notice from time to time. When we do this, we will communicate any changes to you and publish the revised privacy notice on our website.

What data we need to collect and use?

To provide this service, we will collect and use some or all of the personal information below:

- Name
- Address and details of property receiving the WECA funding and retrofit installation
- Details about the expected energy, carbon and cost savings expected to be delivered by the installation, including pre and post-installation property EPC details where appropriate
- Email address
- Phone number

We get most of this information from you and from what we learn about you through your use of our services, but we may also get some information about you from:

How do we use your personal information?

We use this information for one or more of the following reasons:

The purpose(s) for which we are processing your personal data is to support the delivery and administration of The Retrofit Project and WECA Scheme (Sustainable Warmth) (together the Scheme).

Delivery and administration of the Scheme may require linking of your data to other datasets held by Bristol City Leap or WECA.

WECA will be conducting an evaluation of the Scheme. This may include you being contacted to take part in further research. Where the research involves processing of personal data in addition to that already collected for delivery of the Scheme, you will be given the opportunity to opt-in to that research at the point of contact.

Personal information

Our legal basis for using your personal information is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller (Article 6 (1) (e)). Specifically, this data sharing and processing is required in order for:

How long we will keep your personal information?

We will hold this information for as long as it is needed, or if we are required to do so by law. In practice this means that your personal information may be retained for the relevant period listed below:

• Personal information – 6 Years

After this, your personal information will be deleted.

Your rights as a data subject
