Foreword

The Childcare Act 2006 (sections 7, 12 and 13) and 2016 (sections 1 and 2) place a duty on every local authority to 'secure sufficient childcare, so far as is reasonably practicable, for working parents, or parents who are studying or training, for children aged 0-14 (or up to 18 for disabled children)'. Under these duties, Bristol City Council is required to undertake an annual childcare assessment and report this to Council Members to demonstrate that the duty is being met. This report provides an analysis of this assessment to inform decisions about Bristol's current or future childcare needs and is available for parents and providers to use.

All providers were invited to complete the survey between July and September 2022, reflecting on their sufficiency in April 2022.

Introduction

This assessment shows a ward-by-ward overview of the childcare market as at April 2022 with a citywide summary at the end. The Childcare market in every local authority changes on a frequent basis, not only as the academic year progresses but also as new providers of childcare open and close their businesses.

Throughout this document, there is a strong focus on the Free Early Education Entitlement (FEEE). The delivery of the FEEE through childcare providers to families in Bristol is governed by statutory guidance from the Department for Education (DfE) and covers three main areas:

- 15 hour entitlement for Eligible 2 year olds:
- 15 hour entitlement for parents of 3 and 4 year olds (the Universal Free Hours); and
- 30 hour entitlement for working parents of 3 and 4 year olds (the Extended Free Hours)

Executive Summary

Bristol is sufficient in the availability of childcare places for all ages but this is dependent on parents being able to access childcare in wards citywide. There are wards where places have less availability than others across all age groups (St George West, Stoke Bishop and Windmill Hill) In 2023/24 the Early Years Team will work with the providers within these wards to increase availability in line with the current Bristol City Council Corporate Strategy which highlights the importance that 'every child gets the best start in life' (Theme 1: Children and Young People).

Parents need providers to provide a clearer charging structure for childcare costs and the Early Years Team will work with providers to support them in more transparent business practices as well as making information about providers more readily available through the Family Information Service website.

A better understanding of the Breakfast / After-school / Holiday club sectors is needed to ensure sufficient childcare places. The Early Years Team will engage more with these sectors in 2023/24.

Demographics of Bristol

About Bristol

There are approximately 460,000 citizens living in Bristol from over 187 countries, speaking 91 languages and practising 45 religions. Bristol is the largest city in the South West and one of the 11 'Core Cities' in the United Kingdom

Of these citizens, 28,000 are under 5 years old.




Ward Comparison for Child Poverty, 2021

Deprivation

The Ministry of Housing, Communities and Local Government release statistics regarding deprivation called the <u>English Indices of Deprivation</u> (currently 2019). Wards are measured in small local area levels based on seven different facets of deprivation:

- 1. Income Deprivation
- 2. Employment Deprivation
- 3. Education, Skills and Training Deprivation
- 4. Health Deprivation and Disability
- 5. Crime
- 6. Barriers to Housing and Services
- 7. Living Environment Deprivation

Employment

Employment and un-employment are key factors in the eligibility of some of the free entitlements. In December 2021, the employment rate in Bristol was 78.1% with 2,555,100 working age residents in employment. This rate is the highest of the UK Core Cities (see below) and above the national rate of 74.8%

In March 2022, 12,670 working age residents were claiming out of work benefits (4% of the city's population) which has been steadily decreasing over the past year (from 6.1% in March 2021).

Statistical Neighbours

Similar to Core Cities, Bristol has neighbouring local authorities – Bournemouth Christchurch & Poole, Brighton and Hove, Coventry, Derby, Leeds, Plymouth, Portsmouth, Reading, Sheffield and Southampton. These are similar to our size and demographics. Reviewing local authorities of comparable size and demographic help us to validate our progress, e.g., in the take up of the free hours.


In Summer 2022, Bristol's take up of Eligible 2 year olds was ranked 9th out of 11 of our statistical neighbours and 7th for the take up of free hours for 3 and 4 year olds.

We also take note of regional and national trends. In Summer 2022, Bristol's take up of Eligible 2 years was 71%, which was slightly behind the national take up of 72% and regional take up of 80%. For 3 and 4 year olds, Bristol's take up was 90%, again just shy of the national take up of 92% and regional take up of 95%.

Housing

There were 2,563 dwellings (net) were completed in Bristol between 1st April 2021 and 31st March 2022. This is an increase of 974 dwellings on the previous year's figure of 1,589 (see figure 1 below). Between 2006 and 2022 the highest growth has occurred in Central and Lawrence Hill wards with 6,198 and 2,569 dwellings completed respectively. It is worth noting that 14.5% of all dwellings completed in 2021/22 were student units.

Number of children per ward by age

Changes to Population

Since the last census in 2011, the population of Bristol has increased by 10%, however the under 5 year old age group did not increase and there was a minor reduction (4%), which is predicted to recover by 2023 (from projections taken in 2018).




Supply of Childcare & Childcare Market in Bristol

Children attending a childcare provider are only limited by the admissions criteria each provider sets out in their individual policy. Unlike school age children, this means that parents can choose to access childcare wherever they choose and are not limited by catchment zones. Parents can also choose to access childcare in neighbouring local authorities. The only limitation is that to access free childcare, this must be within England, so Bristol's location so close to the Welsh border can sometimes mean that children living in Wales and commuting to Bristol (e.g. for a parent's work) cannot claim.

Distribution of Childcare across Bristol by Provider Type

There are 510 registered providers in Bristol, ranging from independent Childminders to Multi Academy Trusts. A ward breakdown is available in appendix 1.

Availability of Childcare - delivery method

Providers can choose whether to open on a term-time-only (TTO) basis (38 weeks a year) or an all-year-round (AYR) basis (47.5 weeks a year or longer). They may also offer both types of delivery.

Maintained schools and academies tend to operate on a TTO basis, mainly due to the schedule of their older year groups. Childminders and Private providers deliver most of the AYR provision (i.e. throughout the school holidays).

^{*} There were 5 Out of School providers who operated solely during the school holidays.

Availability of childcare - hours

Providers can choose what times to operate, however free childcare is only payable between 06:00 and 20:00. The average day citywide started at 08:30 and closed at 16:30.

The earliest opening time was 07:30 with the latest closing time at 18:00. All sectors are open during core hours (09:00 - 15:30) and all sectors (except nursery classes of academy and maintained sector primary schools) offer 'wrap around' childcare (i.e. provision outside of the core hours) which is essential for working parents.

Days of the Week

Over 90% of group providers are open on weekdays, with none open at weekends. Childminders are mainly open weekdays, with a significant reduction on Fridays.

When combined, the most frequently opened weekday is Wednesday, with the least frequently opened weekday is Friday. Only a small minority of providers are open at weekends.



Providers offering Free Early Education Entitlement

Whilst offering free hours is voluntary for any childcare provider, it is a driving force behind the demand for places across England. In Summer 2022, 94% of all childcare providers were offering free places.

Providers offering Eligible 2 year old places, 3 and 4 year old places and 30 hours

Childcare providers who have a good or outstanding Ofsted judgment can choose to offer places to children a year earlier than the start of their universal free entitlement. Eligibility of children is determined by a national criteria based in the majority on household income under £15,400 per annum. In Summer 2022, 62% of all providers offering free hours offered places to Eligible 2 year olds.


All childcare providers offer places to 3 and 4 year olds. The majority also offer '30 hours' places to children. Eligibility of children is determined by a national criteria based in the majority on household income between £152 per week and £100,000 per year per parent. In Summer 2022, 90% of all providers offering free hours offered 30 hours.

Children with Special Educational Needs and Disabilities (SEND)

Children in Bristol are supported with their SEND in many ways, including through;

- Support and training from Portage and Inclusion Workers including onsite visits
- Portage home visiting service
- Makaton training
- Educational Psychology support
- Bristol Autism Team
- Additional funding (Early Years SEN Panel)
- A graduated approach

Providers in Bristol are supported with the delivery of SEND places through:

- Early years Level 3 SENCO award
- Dingley's Promise
- Ordinarily Available Provision (OAP)
- Local Offer

The take up of the Free Early Education Entitlement of children with SEND in Bristol is high in relation to Local Authorities nationally.

In the Summer Term 2022 we looked at the children attending nursery to Year 2 in primary school who had an Education, Health and Care Plan (EHCP), of these children 88% had accessed their early education.

We also receive data from the Department for Work and Pensions (DWP) on the number of Eligible 2 year olds who claim Disability Living Allowance (DLA) and consistently 89% of these children are attending an early years setting. Our Early Years Inclusion Officer provides dedicated support to parents whose children claim DLA to support them in accessing a place for their child and ensures the setting are able access the appropriate training if required to support a child.

The Early Years Service provides support to all early years providers from the Early Years Portage and Inclusion Team to ensure they feel confident in including children with SEND. The team offers SENCO Network sessions across the city, they also provide various training opportunities both on a city wide basis and also for Inset Days at individual settings as well as offering each early years setting up to 6 visits a year.

Early Years SEND Panel Funding

We have in place an Early Years SEN Panel (also called Inclusion Funding) which enables early years providers to apply for additional funding to enable them to include children with SEND. The funding is allocated to support children for the total number of hours they attend the setting covering paid as well as funded hours.



Education, Health and Care Plans (EHCP) in Early Years

Whilst an EHCP is not required to enable children to access their early years provision, Early Years SEN Panel funding is available. The blue line on the graph below shows that since 2020 the number of children under 5 years old who have been issued with an EHCP has increased by 103%.



The graph to the left shows the number of EHCPs by age over time for Bristol Citizens. The blue line on the graph is for children under 5 years of age.

Disability Access Fund (3 and 4 year olds)

Children who are claiming Disability Living Allowance (DLA) can claim Disability Access Fund (DAF) from the term after their 3rd birthday. In Summer 2022, there were 41 children claiming DAF, with Hartcliffe and Withywood the highest ward, with 10x children.

Portage

Supported by a team of Portage and Inclusion Specialists, Bristol offers a home visiting service sharing educational and support services for children from birth to 4 years old. Parents and professionals can refer children for this service, which supports children through play.

In the Summer of 2022, 104 children were using the Portage service, supported by a team of Inclusion Specialists.

Eligible 2 year olds (eligible due to claiming Disability Living Allowance (DLA)

Children who are eligible for Disability Living Allowance (DLA) are eligible for a 2 year old place from the term after their 2nd birthday. The Department for Work and Pensions (DWP) shares a list 7 times a year with every local authority of children living in their ward who can apply. Children are not required to only take up within their own local authority.

Of the number of children who were eligible for a 2 year old place in April 2022, 2.9% were eligible as they were claiming DLA. Of these children, 86% were taking up a free place. Over the last 3 years, the average take up has been 78%.

Vulnerable Children

Enhanced Provision

Early Years <u>Enhanced Provision</u> provides dedicated childcare for children under 2 years of age who are provided with 12 hours a week childcare over 48 weeks of the year; usually provided over 2 days.

Children are referred by a professional working with the family and are scored against a criteria, priority is given to children who score the highest points.

The Early Years Placement Officer Team manage the placements of all children accessing enhanced provision. They are also responsible for ensuring there is a network of Enhanced Provision Childminders across the city that are experienced, trained and supported in providing high quality day care for children accessing enhanced provision.

In the Summer of 2022, there were 40 children accessing an enhanced provision placement of which 17 (42%) were involved with Social Care and allocated a Social Worker. More Enhanced Provision Childminders are needed in the wards of Eastville, Horfield, Lockleaze, Southmead, St George's Troopers Hill and St George West.

Children in Need / Child Protection

In Summer 2022 there were 457 children under 4 years of age open to Social Care, of which 237 children were eligible to access their free early education entitlement.

- There were 41 children on a Child Protection Plan of which 38 (92.6%) were accessing their free hours
- There were 108 children identified as a Child in Need of which 86 (80%) were accessing their free hours
- There were 32 Children in Care of which 30 (93%) were accessing their free hours
- There were 56 children involved with Families in Focus of which 44 (78.5%)
 were accessing their free hours

Early Years Pupil Premium (EYPP)

Children who are 3 or 4 years old claiming universal free hours whose parents meet the <u>national criteria for Early Years Pupil Premium</u> attract funding for their provider which is used to bridge the gap between them (focusing on their attainment) and their peers from working families.

In Summer 2022, 1,123 children were claiming EYPP in Bristol, with Hartcliffe and Withywood ward having the most claims at 25% of the ward population for that age range.

Voluntary Contributions

Historically, Providers were permitted to ask parents to volunteer to offer additional funding if the hourly rate paid by Bristol City Council was not the same as their standard private hourly rate, however in recent years the Department for Education has moved away from this approach, instead asking Providers to only request a voluntary contribution if they are offering more than the required Early Years Foundation Stage experience in their provision.

The cost of the voluntary contribution varied between £5 and £96 per week. A total of 55 x providers still make these requests.

Consumable Charges

As part of the statutory and operational guidance, providers are permitted and encouraged to charge parents for 'consumables' (nappies, wet-wipes, snacks, trips, activities etc.). In January 2022, Bristol City Council relaunched its campaign with providers to encourage a more transparent approach to charges for consumables and has been working with many providers to re-write their policies.

The cost of the consumables charges varied between £1 and £134 per week. A total of 74 x providers have moved to this model.

Tax Free Childcare (TFC)

Providers are able to register with His Majesty's Revenue and Customs (HMRC) to offer working parents the option to use their Childcare Account to pay for any paid childcare costs (e.g. additional hours, consumable charges etc.). The government adds in 20% of the value paid into the account by the parent.

More than 80% of all providers in Bristol offer this option for parents, which help reduce the cost of childcare. The scheme was launched at the same time as '30 hours' in 2018 and with the cessation of the legacy schemes of child-tax credits and employer vouchers, 81% of parents confirm they are using TFC (see page 27).

Demographics of parent respondents






Proximity to the current childcare

Monday-Friday is the most popular reply.


Times of the day when childcare is needed

Parent Survey Conclusions

Caveat: Whilst the data returned by the local authority to the Department for Education shows an approximate 50:50 share of the market between the maintained sector and all others, the majority of parents who completed this survey were from private nurseries.

- 1) Parents are choosing childcare closer to their homes than to their places of employment
- 2) Weekday childcare is by far the most popular day needed by parents with midweek the most popular
- 3) The majority of childcare sessions are needed between 0800 and 1700
- 4) Over 50% of parents are paying more than £100 per week for childcare hours (i.e. not free hours)
- 5) Only 33% of parents are being charged for consumables
- 6) Over 60% of parents felt able to pay for their childcare costs

Using records from our Complaints and Feedback Service as well as the Family Information Service, there were no official complaints made by parents about a lack of childcare places in 2022.

Feedback and Next Steps from Parent Survey

Some parents contacted the local authority to add in personal experience and give feedback on the survey. After listening carefully, in the next survey we will:

- include a free text feedback box for comments
- ask parents how close (or far) they live from their current childcare provider
- clarify the terminology of the 'type' of provision
- ask parents why they have selected childcare on specific days (e.g. for work?)



Under 2 year old Sufficiency

Analysis

Across the city there were 11209 x under 2 year olds. Providers in the ward were offering 3346 places, of which 2661 were occupied in April 2022.

There were 685 x places still available in April 2022 across the city. A ward-by-ward analysis is available in appendix 3

Conclusions

Whilst citywide we are meeting our sufficiency needs for under 2 year olds (both paying privately and in free places), 11 wards (32%) are at their limits of offering places. Neighbouring wards are currently providing support.

Recommendations and Next Steps...

1. Continue to track places, focussing on growing places in priority wards.

2 year old Sufficiency

Analysis

Across the city there were 5763 x 2 year olds. Providers in the ward were offering 4189 places, of which 3294 were occupied in April 2022.

Of those 5763 x 2 year olds, the Department for Work and Pensions informed us of 1419 x children who were eligible for a free place aged 2 (approx. 25% of the 2 year old population). Of those 1419 children, 926 were taking up a free place (approximately 65%)

Including paid and free places, there were 894 x places still available in April 2022 across the city. Neighbouring wards are currently providing support. A ward-by-ward analysis is available in appendix 4.

Eligible 2 year old take up over time

Children are eligible for a 2 year old place from the term after their 2nd birthday. The Department for Work and Pensions (DWP) shares a list 7 times a year with every local authority of children living in their ward who can apply. Children are not required to only take up within their own local authority.

At the January headcount and census, we are measured on the take up of places.

Conclusions

- The majority of places for 2 year olds are taken up by paid places
- Whilst citywide we are meeting our sufficiency needs for 2 year olds (both paying privately and in free places), 11 wards (32%) are at their limits of offering places. Neighbouring wards are currently providing support.
- Not all children who are eligible for a free place are taking up their entitlement (65% in April 2022).

Recommendations and Next Steps...

- 1. Work with providers to review occupancy and affordability of Eligible 2 year old places with the impending hourly rate increase in 23/24
- 2. Maintained take up of free places for those children who are eligible to 71%, in line with national average take up.

3 and 4 year old Sufficiency

Analysis

Across the city there were 11394 x 3 and 4 year olds. Providers in the ward were offering 9500 places, of which 7543 were occupied in April 2022.

Of those 11394 x 3 and 4 year olds who were all eligible for a free place, 6400 were taking up a free place (approximately 85%)

Including paid and free places, there were 1957 x places still available in April 2022 across the city. A ward-by-ward analysis is available in appendix 5.

Conclusions

• The majority of places for 3 and 4 year olds are taken up by free places

- Whilst citywide we are meeting our sufficiency needs for 3 and 4 year olds (both paying privately and in free places), 5 wards (15%) are at their limits of offering places. Neighbouring wards are currently providing support.
- Not all children who are eligible for a free place are taking up their entitlement (85% in April 2022).

Recommendations and Next Steps...

- 1. Work with providers to review occupancy and affordability of 3 and 4 year old places with the impending hourly rate increase in 23/24
- 2. Improve take up of free places for those children who are eligible to 80%, in line with national average take up.

5-14 year olds Sufficiency

Analysis

Across the city there were 56,574 5-14 year olds. Providers who submitted a response confirmed they were offering 2977 places, of which 2245 were occupied in April 2022.

There were 732 x places still available in April 2022 across the city. A ward-by-ward analysis is available in appendix 6

Conclusions

 Children aged between 5-14 years old are of statutory school age and therefore require less childcare, which is usually delivered through Breakfast / After-school / Holiday club providers, however only 42% responded to the survey. As the data set is incomplete, further analysis was not possible, but for those who did respond, their places were sufficient.

Recommendations and Next Steps...

1. Work with Breakfast / After-school / Holiday club providers to encourage their engagement with future surveys.

Conclusions & Recommendations

Parent Survey Conclusions

The supply of childcare is meeting the demand by parents, in that the days and times where childcare is needed are the same as days (weekdays) and times (0800-1700) being provided. With a stronger requirement for providers to move away from the model of asking parents for voluntary contributions (and instead creating a consumables charge), the low number of parents who responded to the survey stating they were being asked to pay for consumables is lower than expected (33%). We were pleased there were no official complaints made by parents about a lack of childcare places in 2022.

Parent Survey Recommendations

- 1. The Early Years team will continue to strongly encourage providers to continue to create consumables charges for parents and provide help through business support sessions on a one to one basis for any provider who asks.
- 2. Improvements will be made to the next parent survey to include a free text feedback box for comments, to ask parents how close (or far) they live from their current childcare provider and ask parents why they have selected childcare on specific days (e.g. for work?)
- 3. The Early Years team will continue to work on providing better information to parents through the <u>Family Information Service webpage</u> and encourage providers to supply updated information online.

Sufficiency Conclusions

At the time of the assessment, we are sufficient for childcare places across the city for all age groups. Whilst this meets our legal duty, we are aware of an increased need for more places to enable 100% of all children to access childcare.

Sufficiency Recommendations and Next Steps...

Under 2 year olds - Continue to track places, focussing on growing places in priority wards.

Eligible 2 year olds - work with providers to review occupancy and affordability of places with the impending hourly rate increase in 23/24. Continue to prioritise the take up of free places for those children who are eligible to 71%, in line with national

average. We will review the information we provide to parents online and remove barriers on how to apply, updating our systems.

3 and 4 year olds - work with providers to review occupancy and affordability of 3 and 4 year old places with the impending hourly rate increase in 23/24. Continue to work on improving the take up of free places for those children who are eligible to 80%, in line with national average.

5-14 year olds - work with Breakfast / After-school / Holiday club providers to better understand the availability of childcare for this age group, alongside the Holidays Activities Fund (HAF) programme.

In addition, Bristol City Council will be

- promoting the use of Tax Free Childcare as a means for working parents to support the rising cost of living in Summer 2023.
- reviewing the public information and processes to enable citizens to register to become a childminder.
- working with Childminders more closely to increase the engagement with the next sufficiency assessment.
