

ANTI-SOCIAL BEHAVIOUR CRIME AND POLICING ACT 2014

SECTION 59

PUBLIC SPACES PROTECTION ORDER 2017

HANOVER STREET

BRISTOL CITY COUNCIL (the Council) in exercise of its powers under section 59 of the Anti-Social Behaviour Crime and Policing Act 2014 (the Act) makes the following Order:

1. This Order applies to the public highway known as Hanover Street, Bristol, delineated in dashed red on the plan annexed to this Order (the Restricted Area).
2. The Council is satisfied that the two conditions below have been met, in that:
 - a. Activities (the Activities) carried out in the Restricted area have had a detrimental effect on the quality of life of those in the locality, or it is likely that these Activities will be carried on in the Restricted Area and that they will have such an effect. The said Activities being street drinking, littering, fly-tipping, drug use and violence.
 - b. That the effect, or likely effect of the Activities is, or is likely to be, of a persistent or continuing nature is, or is likely to be, such as to make the Activities unreasonable and justifies the restrictions imposed by the Order.
3. The effect of this Order is as follows:
 - a. To restrict the use of the public highway within the Restricted Area, the restriction being in place at all times.
 - b. There is authorised the installation, operation and maintenance of a barrier or barriers to enforce the restrictions in this Order.
4. The restriction in this Order shall not apply to any registered owner of, or person who lives or works in, premises adjoining the Restricted Area, or to any police, ambulance or fire service personnel, acting in pursuance of their statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus located in the Restricted Area, or persons and/or vehicles required in connection with maintenance work or other functions of the Council.
5. Any person who without reasonable excuse fails to comply with the requirements of the Order commits an offence and shall be liable, on summary conviction, to a fine not exceeding level 3 on the standard scale.
6. A Fixed Penalty Notice may be issued to a person who a constable or authorised person has reason to believe has committed an offence in relation to this Order, offering the person to whom it is issued the opportunity of discharging any liability to conviction for the offence by payment of a fixed penalty.

7. If any interested person desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within 6 weeks from the date on which this Order is made.
8. The Order shall come into operation on 1 June 2017 and shall remain in place for a period of 3 years.
