DECLARATION OF LICENCE HOLDER THAT INTEREST IN A LICENSED VEHICLE HAS
BEEN TRANSFERRED TO NEW PROPRIETOR

49 (i) If the proprietor of a Private Hire Vehicle / Hackney Carriage in respect of which a vehicle licence has been granted by a district council transfers his interest in the Private Hire Vehicle / Hackney carriage to a person other than the proprietor whose name is specified on the licence, he shall within fourteen days after such transfer give notice in writing thereof to the district council specifying the name and address of the person to whom the Private Hire Vehicle / Hackney Carriage has been transferred

49 (ii) If a proprietor without reasonable excuse fails to give notice to a district council as provided by subsection (i) of this section he shall be guilty of an offence.
