

# **Privacy Notice**

Bristol City Council is the data controller for the purposes of the Data Protection Act 2018 and other regulations including the General Data Protection Regulation (Regulation (EU) 2016/679), which means it determines what your personal data is used for and why it is collected. The purpose of this privacy notice is to tell you about how we collect and use personal data in connection with our service. We may update this privacy notice from time to time. When we do this, we will communicate any changes to you and publish the revised privacy notice on our website.

#### What data we need to collect:

To provide this service, we will process your name, address, email address, telephone number and business address (when provided).

If you don't allow us to use your data this will mean that Bristol City Council cannot provide this service.

## How long we will keep your data for:

We will/may hold this information for up to 6 years from date of application. After this, your information will be deleted.

#### Why we need to collect your data:

We will use this information for the provision and management of the service, as designated under relevant national legislation and Pavement Licences issued by Bristol City Council.

#### Who else might we share your personal information with?

Sometimes we may need to share your information, but we will only do so where we have your consent or it is necessary or required by law. We will only share the minimum information for each circumstance.

#### What is the legal basis for our use of your personal information?

The information below shows the legal bases we are relying on to use your personal or special category (sensitive) personal information. You can see a list of the full legal bases we may rely on by looking at our main privacy notice.

#### **Personal information**

Our legal bases for using your personal information are to *meet our legal obligations*\_in order for Bristol City Council to fulfil its obligations as the Highway Authority and to manage the use of the Highway under the Highways Act 1980 and the Business and Planning Act 2020

### Your rights as a data subject:
