

# Bristol Libraries Book Bingo 2026: Prize Draw Terms and Conditions

## 1. Promoter

The promoter of this prize draw is Bristol Libraries (Bristol City Council).

## 2. Eligibility

- The prize draw is open to individuals who:
    - Are members of Bristol Libraries or Libraries West (visiting Bristol Libraries to take part)
    - Are aged 16 or over
  - Entry is free.
- 

## 3. How to Enter

To enter the prize draw, participants must:

1. Sign up to the Bristol Libraries Book Bingo 2026 challenge online or in a Bristol library.
2. Collect a Book Bingo card and complete the challenge by reading or listening to books matching the categories on the card.
3. Submit a completed Bingo card by the closing date.

Participants may mark off categories themselves, or have their card stamped by library staff. Accepted formats include physical books, eBooks and audiobooks.

## 4. Entry Period

- The challenge runs during 2026.
  - Completed cards can be submitted from 1 June 2026.
  - The closing date for entries is **23:59 on Thursday 31 December 2026**.
  - Entries received after this date will not be included.

## 5. Submitting Entries

Completed cards may be submitted by:

- Uploading a photo or scan via the official online form, or
- Returning the card in person at any Bristol library, where library staff will complete the online form for them

Only completed entries will be eligible for the prize draw.

## 6. The Prize

- One winner will receive a £100 book token.
  - The prize is non-transferable and non-exchangeable. No cash alternative is available.

## 7. Winner Selection and Notification

- The winner will be selected at random from all eligible entries.
  - The draw will take place after the closing date.
  - The winner will be contacted using the details provided on submitting finisher's form.
  - If the winner does not respond within a reasonable time (e.g. 14 days), Bristol Libraries reserve the right to select an alternative winner.

## 8. Data Protection

- Personal data collected as part of this challenge will be used for administering the Book Bingo challenge and managing the prize draw
  - Data will be handled in accordance with Bristol City Council's privacy policies.
  - Participants will not be added to marketing lists without consent.
- 

## 9. Publicity

- By entering, participants agree that their first name may be used to announce the winner
  - No further publicity will be used without explicit consent.
- 

## 10. General

- Bristol Libraries reserve the right to:
    - Amend or withdraw the challenge or prize draw if necessary
    - Disqualify entries that do not comply with these terms
  - By entering, participants agree to be bound by these Terms and Conditions.
  - In case of dispute, the decision of Bristol Libraries is final.
