The City Council of Bristol (hereinafter referred to as “the Council”) in exercise of its powers under sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following order:-

PART I
COMMENCEMENT, CITATION AND INTERPRETATION

Commencement and citation

1. This order shall come into operation on ----- and may be cited as the City Council of Bristol (Various Roads, St. George Area, Lawrence Hill, Easton, St. George Central, St. George Troopers Hill and St. George West Wards, City of Bristol) (Prohibition and Restriction of Waiting) (Prohibition of Stopping) (Loading Places) (Bus Parking Places) (Disabled Persons' Parking Places) (Car Club Parking Places) (E-Scooter and Cycle Hire Parking Places) Order No.2 202-.

Interpretation

2. (1) In this order:-

“**authorised cab rank**” means any area of carriageway which is comprised within and indicated by road marking diagram 1028.2 as provided for at item 5 of the sign table in Part 4 of Schedule 7 to the Traffic Signs Regulations and General Directions 2016, as amended;

“**authorised parking place**” means any parking place on a road authorised or designated by an order made or having effect as if made under the Act of 1984;

“**authorised vehicle**” means any vehicle authorised by an order to use any authorised parking place authorised or designated by that order made or having effect as if made under the Act of 1984;

“**bus**” has the same meaning as in Schedule 1 to the Traffic Signs Regulations and General Directions 2016, as amended;

“**bus parking place**” means an area on a carriageway authorised by Article 29 of this order as a parking place for buses;

“bus stop clearway” in relation to a length or side of road means all that area of carriageway which is bounded by the outer line of road marking diagram 1025.1 as provided for at item 9 of the sign table in Part 4 of Schedule 7 to the Traffic Signs Regulations and General Directions 2016, as amended;

“Car Club” means a city Car Club or similar organisation (including any person or organisation acting on behalf of such club or organisation) approved in writing by the Council for the purposes of this order;

“Car Club parking place” means an area on a carriageway designated as a Car Club parking place by Article 68 of this order;

“Car Club vehicle” means a vehicle of a type approved by the Council and provided by a Car Club or by the Council for the use of persons who have paid any relevant membership or other Car Club fee and by means of a real-time or advance booking system may have use of the vehicle for a specified period and which displays the relevant identification issued and/or approved by the Council;

“carriageway” means a way constituting or comprised in a highway, being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

“civil enforcement officer” has the same meaning as in section 76 of the Traffic Management Act 2004;

“delivering” and **“collecting”** in relation to any goods includes checking the goods for the purpose of their delivery or collection;

“disabled person” means a disabled person of a description prescribed by The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000, as amended;

“disabled person’s badge” has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000, as amended;

“disabled persons’ parking place” means an area on a carriageway authorised by Article 47 or Article 48 of this order;

“disabled person’s vehicle” means:-

- (a) a vehicle which is lawfully displaying a disabled person’s badge in the relevant position and is a vehicle which, immediately before or after any period of waiting allowed by a provision of this order, has been or is to be driven by a disabled person or, as the case may be, has been or is to be used for carrying one or more disabled persons as passengers; or
- (b) an invalid carriage as prescribed in Section 136 of the Act of 1984;

“driver” in relation to a vehicle waiting in a loading place, bus parking place, disabled persons’ parking place, Car Club parking place or e-scooter and cycle hire parking place means the person in charge of the vehicle at the time it was left in the loading place, bus parking place, disabled persons’ parking place, Car Club parking place or e-scooter and cycle hire parking place and where a separate person acts as steersman of a vehicle, includes that person as well as any other person in charge of the vehicle, and **“drive”** shall be construed accordingly;

“e-scooter and cycle hire parking place” means an area on a carriageway authorised by Article 85 of this order as a parking place for electric scooters and electrically assisted pedal cycles;

“electrically assisted pedal cycle” means an electric cycle as defined in the Electrically Assisted Pedal Cycles Regulations 1983 as varied;

“electric scooter” means an electric scooter as defined in The Electric Scooter Trials and Traffic Signs (Coronavirus) Regulations and General Directions 2020;

“electronic communications apparatus” means apparatus comprised in or to be comprised in an electronic communications network as defined in the Communications Act 2003;

“enactment” means any enactment whether public, general or local and includes any order, byelaw, regulation, scheme or other instrument having effect by virtue of an enactment;

“goods” means goods of any kind whether animate or inanimate and includes postal packets of any description;

“goods vehicle” means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description, or a trailer so adapted;

“hackney carriage” has the same meaning as in section 38 of the Town Police Clauses Act 1847 but complying with the requirements of the relevant licensing authority in respect of roof-top signs;

“immobilisation exempt vehicle” means:-

- (i) a disabled person’s vehicle or an invalid carriage;
- (ii) a vehicle which displays a local exemption parking permit which has been issued by the Council to a doctor, district nurse, midwife or other medically or otherwise professionally qualified person for use when engaged in emergency duties, and is subject to conditions or limitations imposed upon its use by the Council; or
- (iii) a diplomatic registered vehicle in the execution of official duties;

“invalid carriage” has the same meaning as in Section 136 of the Act of 1984;

“loading place” means any area on a carriageway authorised as a loading place by Article 11 or Article 12 of this order;

“local service” has the same meaning as in the Transport Act 1985;

“motor cycle” and **“motor vehicle”** have the same meaning as in Section 136 of the Act of 1984;

“parking disc” has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) (Regulations) 2000;

“passenger vehicle” means a motor vehicle (other than a motor cycle or invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than eight passengers exclusive of the driver and not drawing a trailer;

“plans” means the drawings which are annexed hereto as specified in the Schedule to this order;

“police community support officer” has the same meaning as in section 38 of the Police Reform Act 2002;

“postal packet” has the same meaning as in the Postal Services Act 2000;

“provision of a universal postal service” has the same meaning as in the Postal Services Act 2000;

“relevant identification” means a badge or other means of identification issued and/or approved by the Council indicating that a vehicle on which it is displayed is provided by or on behalf of a Car Club and may validly be left in a Car Club parking place;

“relevant position” has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

“rider” in relation to a vehicle waiting in an e-scooter and cycle hire parking place means the person in charge of the vehicle at the time it was left in the e-scooter and cycle hire parking place, and where a separate person acts as steersman of a vehicle, includes that person as well as any other person in charge of the vehicle;

“traffic sign” has the same meaning as in Section 64 of the Act of 1984;

“universal service provider” has the same meaning as in the Postal Services Act 2000; and

“vehicle” means any vehicle, whether or not it is in a fit state for use on a road, and includes any chassis or body, with or without wheels, appearing to have formed part of such a vehicle, and any load carried by and anything attached to such a vehicle.

- (2) Any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

PART II **WAITING OF VEHICLES**

Prohibition and Restriction of Waiting of Vehicles

3. Save as provided in Article 8 and Article 9 of this order no person shall, except upon the direction or with the permission of a civil enforcement officer, a police constable in uniform or a police community support officer, cause or permit any vehicle to wait in any of the lengths of road or sides of road identified as **No waiting at any time** in the plans.
4. Save as provided in Article 8 and Article 9 of this order no person shall, except upon the direction or with the permission of a civil enforcement officer, a police constable in uniform or a police community support officer, cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday in any of the lengths of road or on any of the sides of road identified as **No waiting Mon - Sat 8 am - 6 pm** in the plans.
5. Save as provided Article 8 and Article 9 of this order no person shall, except upon the direction or with the permission of a civil enforcement officer, a police community support officer or a police constable in uniform cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day other than a Sunday in any of the lengths of road or on any of the sides of road identified as **Limited waiting Mon - Sat 8 am - 6 pm 1 hour No return within 1 hour** in the plans:-
- (i) for a longer period than one hour; or
- (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same length of road or on the same side of road.
6. Save as provided Article 8 and Article 9 of this order no person shall, except upon the direction or with the permission of a civil enforcement officer, a police community support officer or a police constable in uniform cause or permit any vehicle to wait between the hours of 5.00 p.m. and 9.30 p.m. on any day in any of the lengths of road or on any of the sides of road identified as **Limited waiting Mon - Sun 5 pm – 9:30 pm 30 mins No return within 2 hour** in the plans:-
- (i) for a longer period than 30 minutes; or

- (ii) if a period of less than two hours have elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same length of road or on the same side of road.

Prohibition of stopping of Vehicles

7. Save as provided in Article 10 of this order no person shall, except upon the direction or with the permission of a civil enforcement officer, a police community support officer or a police constable in uniform, cause or permit any vehicle to stop or remain at rest between the hours of 8.00 a.m. and 6.00 p.m. on any day other than Saturday or Sunday in any of the lengths of road or on any of the sides of road identified as **No stopping Mon - Fri 8 am - 6 pm on entrance markings** in the plans.

Exemptions

8. (1) Nothing in Article 3 or Article 4 or Article 5 or Article 6 of this order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of roads or on any of the sides of roads referred to in those articles for so long as may be necessary to enable:-
- (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial, demolition or excavation operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of road or sides of road;
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, the said lengths of road or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in the Communications Act 2003; or
 - (v) the construction, installation, improvement, maintenance, repair or cleaning of any traffic sign, bus stop infrastructure or other street furniture or other object lawfully placed or to be placed on, in or over the said lengths of roads or sides of roads;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority, the Environment Agency, a water undertaker or sewerage undertaker in pursuance of statutory powers or duties;

- (d) the vehicle to be used by a universal service provider for the purpose of delivering or collecting postal packets in the course of the provision of a universal postal service;
- (e) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of road or sides of road;
- (f) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of roads or sides of roads for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral; or
- (g) the vehicle to be used for fire and rescue service, ambulance or police purposes -

Provided that the exemption conferred by this paragraph in relation to the uses specified in sub-paragraphs (e) and (f) hereof shall not apply so as to exempt any vehicle from the prohibition contained in the said Articles in so far as they apply to the lengths of roads or sides of roads identified as **No loading / unloading at any time** in the plans.

- (2) Nothing in Article 3 or Article 4 or Article 5 or Article 6 of this order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road or on any of the sides of road referred to in those Articles for so long as may be necessary to enable goods to be loaded on to or unloaded from the vehicle -

Provided that the exemption conferred by this paragraph shall not apply so as to exempt any vehicle from the prohibitions contained in the said Articles in so far as they apply to the lengths of road or sides of road identified as **No loading / unloading at any time** in the plans.

- (3) Nothing in Article 3 or Article 4 or Article 5 or Article 6 of this order shall render it unlawful to cause or permit any vehicle:-
 - (a) being an authorised vehicle, to wait upon an authorised parking place;
 - (b) being a hackney carriage, to wait upon an authorised cab rank; or
 - (c) being a bus used in the provision of a local service to wait in any bus stop clearway for the purposes set out in Part 6 of Schedule 7 to the Traffic Signs and Regulations and General Directions 2016, as amended.

9. (1) Nothing in Article 3 or Article 4 of this order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of roads or on any of the sides of roads referred to therein for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length or on the same side of road on the same day).
- (2) Nothing in Article 5 or Article 6 of this order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in any of the lengths of roads or on any of the sides of roads referred to in those Articles –

Provided that no disabled person's vehicle shall wait at any time in the lengths of roads or sides of roads identified as **No loading / unloading at any time** in the plans.

10. Nothing in Article 7 of this order shall render it unlawful to cause or permit any vehicle to stop or remain at rest in any of the lengths of road or on any of the sides of road referred to therein for so long as may be necessary to enable:-
- (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
- (i) the maintenance, improvement or reconstruction of the said lengths of road or sides of road;
 - (ii) the laying, erection, alteration or repair in, or in land adjacent to, the said lengths of road or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in the Communications Act 2003; or
 - (iii) the construction, installation, improvement, maintenance, repair or cleaning of any traffic sign, bus stop infrastructure or other street furniture or other object lawfully placed or to be placed on, in or over the said lengths of road or sides of road;
- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority, the Environment Agency, a water undertaker or sewerage undertaker in pursuance of statutory powers or duties;
- (c) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of road or sides of road;
- (d) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of road or sides of road for so long as such waiting by that vehicle is reasonably necessary in connection with any funeral; or
- (e) the vehicle to be used for fire and rescue service, ambulance or police purposes.

PART III

LOADING PLACES

Authorisation and Use of Loading Places

11. Each area of a carriageway which is identified as **Loading only** in the plans (and unless otherwise so indicated on the said plans, bounded on one side of that length by the edge of the carriageway) is hereby authorised to be used as a loading place, subject to the following provisions of this order.
12. Each area of a carriageway which is identified as a **Loading only Mon - Fri 7 am - 5 pm** in the plans (and unless otherwise so indicated on the said plans, bounded on one side of that length by the edge of the carriageway) is hereby authorised to be used between the hours of 7.00 a.m. and 5.00 p.m. on any day other than a Saturday or Sunday, subject to the following provisions of this order, as a loading place.

Vehicles for Which Loading Places are Authorised

13. Each loading place may be used, subject to the provisions of this order, for the leaving of such vehicles as are goods vehicles and passenger vehicles for the purpose:-
 - (a) of continuous loading and unloading; or
 - (b) of returning or collecting goods previously purchased at premises in the vicinity of the loading place which cannot reasonably be carried by hand and provided that a recent sales receipt is held in respect of such goods.
14. The limits of each loading place shall be indicated on the carriageway by appropriate traffic signs.

Manner of Standing in Loading Places

15. The driver of a vehicle waiting in a loading place shall cause it so to stand:-
 - (a) on a road in a single line parallel to the edge of the carriageway and so that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than 300 millimetres; and
 - (b) so that every part of the vehicle is wholly within the limits of a single loading place.

Restriction of Use of Vehicles at Loading Places

16. The driver of a vehicle using a loading place shall stop the engine as soon as the vehicle is in position in the loading place and shall not start the engine except when about to change the position of the vehicle in, or to depart from, the loading place.
17. The driver of a vehicle in a loading place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the loading place.

18. No person shall use any vehicle whilst it is in a loading place for the purposes of or in connection with the sale of or the attempted sale of any article directly from the vehicle to any person in or near the loading place or in connection with the selling or offering for sale of his skill or his services in any other capacity.
19. No person shall use any vehicle whilst it is in a loading place to carry out or permit the carrying out of any work of maintenance or repair or the washing down of any vehicle except such maintenance or repair as may be necessary to enable the vehicle to be moved from the loading place.

Restriction of Waiting in Loading Places

20. Save as provided in Article 21 of this order no person shall leave a vehicle in a loading place:-
 - (a) unless the vehicle is in accordance with the provisions of Article 13 of this order; and
 - (b) in a position other than that specified in Article 15 of this order.

Restriction of Waiting by Vehicles in Loading Places

21. (1) Without prejudice to the foregoing provision of this order with respect to vehicles which are left in a loading place in accordance with those provisions, any other vehicle may wait anywhere on the carriageway within a loading place (other than a loading place or part thereof the use of which has been suspended) if:-
 - (a) the vehicle is waiting for a period not exceeding two minutes, or such longer period as a civil enforcement officer, a police constable in uniform or a police community support officer may approve, to enable a person to board or alight from the vehicle or load thereon or unload therefrom his personal luggage -

Provided that if the said person is a person suffering from any disability or injury which seriously impairs his ability to walk or who is blind, the vehicle may wait for as long as may be necessary to enable that person to board or alight from the vehicle or load thereon or unload therefrom his personal luggage;
 - (b) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (c) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;

- (d) the vehicle is being used for fire and rescue service, ambulance or police purposes or is a vehicle (other than a passenger vehicle) in the service of a local authority being used in pursuance of statutory powers or duties;
 - (e) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
 - (f) the vehicle is to be used by a universal service provider in the course of the provision of a universal postal service for the purpose of delivering or collecting postal packets to or from premises adjacent to the loading place or for the purpose of delivering to or collecting from posting boxes adjacent to that loading place;
 - (g) the vehicle is waiting only so long as may be reasonably necessary to enable it to be used for the purpose of the maintenance, installation or removal in or adjacent to the loading place of any traffic sign, bus stop infrastructure or other street furniture; or
 - (h) the vehicle is waiting only for so long as is necessary to enable it to be used in connection with posting or removing advertising material in the form of posters on or from, or cleaning windows or chimneys in, premises adjacent to the loading place in which the vehicle is waiting.
- (2) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act of 1984.

Manner of Standing by Exempted Vehicles in Loading Places

22. A person causing or permitting a vehicle to wait in a loading place by virtue of the provisions of sub-paragraph (f), (g) and (h) in paragraph (1) of the last preceding Article shall ensure that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and nearest wheel of the vehicle is not more than three hundred millimetres.

Power to Suspend the Use of Loading Places

23. (1) Any person generally or specially authorised by the Council may suspend the use of a loading place, or any part thereof, whenever that person considers such suspension reasonably necessary:-
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building, industrial, demolition or excavation operations in or adjacent to the loading place;
 - (c) for the purpose of the maintenance, improvement or reconstruction of the loading place;

- (d) for the purpose of the laying, erection, alteration, removal or repair in or adjacent to the loading place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus;
 - (e) for the purpose of the maintenance, installation or removal in or adjacent to the loading place of any traffic sign, bus stop infrastructure or other street furniture;
 - (f) for the convenience of occupiers of premises adjacent to the loading place on any occasion of the removal of furniture or household effects to or from premises adjacent to the loading place;
 - (g) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (h) for the convenience of occupiers of premises adjacent to the loading place at times of weddings or funerals, or on other special occasions.
- (2) A police constable in uniform or a police community support officer may suspend for not longer than 7 days the use of a loading place or any part thereof whenever that police constable or police community support officer considers such suspension reasonably necessary for the purpose of preventing or mitigating congestion or obstruction of traffic, or danger to or from traffic, in consequence of extraordinary circumstances.
- (3) Any person suspending the use of a loading place or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed over the traffic signs relating to such loading place hoods or other covers indicating that the use of the loading place is suspended or a traffic sign indicating that waiting by vehicles is prohibited.
- (4) Exemptions during suspension of loading places

No person shall cause or permit a vehicle to be left in any part of a loading place during such period as there is over the traffic signs relating to that place a hood or other cover (indicating that the use of the loading place is suspended) or during such period as there is in or adjacent to that part of the loading place a traffic sign (indicating that the use of the loading place is suspended) placed in pursuance of paragraph (3) of this Article -

Provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for:-

- (a) fire and rescue service, ambulance or police purposes;
- (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;

- (c) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic -

or if the vehicle is left with the permission of the person suspending the use of the loading place or part thereof in pursuance of paragraph (1) of this Article, or a person duly authorised by him.

Alteration of Position of Vehicles in Loading Places

24. Where a vehicle is standing in a loading place in contravention of the provisions of Article 15 or Article 22 of this order a civil enforcement officer, a police constable in uniform or a police community support officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

Removal of Vehicles from Loading Places and Safe Custody of Vehicles

25. When a vehicle (other than an immobilisation exempt vehicle) is left in a loading place in contravention of any of the provisions of Part III of this order a civil enforcement officer, a police constable in uniform or a police community support officer may remove or arrange for the removal of the vehicle from that loading place, and where it is so removed shall make such arrangement as may be reasonably necessary for the safe custody of the vehicle.

Method of Removal of Vehicles from Loading Places

26. A civil enforcement officer, a police constable in uniform or a police community support officer removing a vehicle by virtue of Article 25 of this order may do so by towing or driving the vehicle, or in such other manner as he may think necessary, and may take such measures in relation to that vehicle as may be thought necessary to enable the removal as aforesaid.

Movement of Vehicles in Loading Places in an Emergency

27. Any person generally or specially authorised by the Council, a civil enforcement officer, a police constable in uniform or a police community support officer may move or cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in a loading place.

Placing of Traffic Signs etc.

28. The Council shall:-
- (a) place and maintain in or in the vicinity of each loading place traffic signs and or carriageway markings of any size, colour and type prescribed or authorised by the Department for Transport indicating that such loading place may be used for the purpose of and leaving only of the vehicles specified in Article 13 of this order; and
 - (b) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a loading place.

PART IV
BUS PARKING PLACES

Authorisation and Use of Bus Parking Places

29. Each area of carriageway which is identified as **Buses only 20 minutes No return within 1 hour** in the plans annexed hereto (and unless otherwise so indicated on the said plan, bounded on one side of that length by the edge of the carriageway) is hereby authorised to be used, subject to the following provisions of this order, as a parking place for buses.
30. The driver of a bus using a bus parking place shall not permit that vehicle to wait in that bus parking place for a longer period than 20 minutes.
31. No bus which has been taken away from a bus parking place shall again be left in that bus parking place until the expiration of one hour from the time it was taken away.
32. The limits of each bus parking place shall be indicated on the carriageway by appropriate traffic signs.

Manner of Standing in Bus Parking Places

33. The driver of a bus waiting in a bus parking place shall cause it so to stand:-
 - (a) if special provisions
in the case of a bus parking place in relation to which special provisions as to the manner of standing of buses in that place are indicated on the carriageway by appropriate traffic signs, so as to be in accordance with those provisions;
 - (b) if no special provisions
in the case of any other bus parking place on a road in single line parallel to the edge of the carriageway and so that the distance between the edge of the carriageway and the nearest wheel of the bus is not more than three hundred millimetres; and
 - (c) so that every part of the bus is wholly within the limits of a bus parking place.

Restriction of Use of Buses at Bus Parking Places

34. The driver of a bus using a bus parking place shall stop the engine as soon as the bus is in position in the bus parking place, unless there are one or more passengers on board, and shall not start the engine except when about to change the position of the bus in, or to depart from, the bus parking place.
35. The driver of a bus using a bus parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the bus parking place.

36. No person shall use any bus whilst it is in a bus parking place for the purposes of or in connection with the sale of or the attempted sale of any article directly from the vehicle to any person in or near the bus parking place or in connection with the selling or offering for sale of his skill or his services in any other capacity.
37. No person shall use any bus whilst it is in a bus parking place to carry out or permit the carrying out of any work of maintenance or repair or the washing down of any vehicle except such maintenance or repair as may be necessary to enable the vehicle to be moved from the bus parking place.

Restriction of Waiting in Bus Parking Places

38. Save as provided in Article 39 of this order no person shall leave a vehicle in a bus parking place:-
- (a) unless it is a bus; and
 - (b) in a position other than that specified in Article 33 of this order.

Restriction of Waiting of Vehicles other than Buses in Bus Parking Places

39. (1) Without prejudice to the foregoing provisions of this order with respect to vehicles which are left in a bus parking place in accordance with those provisions, any other vehicle not being a bus may wait anywhere on the carriageway within a bus parking place (other than a bus parking place or part thereof the use of which has been suspended) if:-
- (a) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
 - (c) the vehicle is being used for fire and rescue service, ambulance or police purposes or is a vehicle (other than a passenger vehicle) in the service of a local authority being used in pursuance of statutory powers or duties;
 - (d) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
 - (e) the vehicle is to be used by a universal service provider in the course of the provision of a universal postal service for the purpose of delivering or collecting postal packets to or from premises adjacent to the bus parking place or for the purpose of delivering to or collecting from posting boxes adjacent to that bus parking place;

- (f) the vehicle is waiting only so long as may be reasonably necessary to enable it to be used for the purpose of the maintenance, installation or removal in or adjacent to the bus parking place of any traffic sign or other street furniture; or
 - (g) the vehicle is waiting only for so long as is necessary to enable it to be used in connection with posting or removing advertising material in the form of posters on or from, or cleaning windows or chimneys in, premises adjacent to the bus parking place in which the vehicle is waiting.
- (2) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act of 1984.

Manner of Standing by Exempted Vehicles in Bus Parking Places

40. A person causing or permitting a vehicle to wait in a bus parking place by virtue of the provisions of sub-paragraph (e), (f) and (g) in paragraph (1) of the last preceding Article shall ensure:-
- (a) in the case of a bus parking place in relation to which special provisions as to the manner of standing of vehicles in that place are indicated on the carriageway by appropriate traffic signs, that the vehicle shall so stand:-
 - (i) unless the length of the vehicle precludes compliance with this sub-paragraph, in accordance with those provisions and so that every part of the vehicle is within the limits of the bus parking place; or
 - (ii) if the length of the vehicle does preclude compliance with the last preceding sub-paragraph that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than three hundred millimetres; and
 - (b) in the case of any other bus parking place, that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and nearest wheel of the vehicle is not more than three hundred millimetres.

Power to Suspend the Use of Bus Parking Places

41. (1) Any person generally or specially authorised by the Council may suspend the use of any bus parking place, or any part thereof, whenever that person considers such suspension reasonably necessary:-
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;

- (b) for the purpose of any building, industrial, demolition or excavation operations in or adjacent to the bus parking place;
 - (c) for the purpose of the maintenance, improvement or reconstruction of the bus parking place;
 - (d) for the purpose of the laying, erection, alteration, removal or repair in or adjacent to the bus parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus;
 - (e) for the purpose of the maintenance, installation or removal in or adjacent to the bus parking place of any traffic sign or other street furniture;
 - (f) for the convenience of occupiers of premises adjacent to the bus parking place on any occasion of the removal of furniture or household effects to or from premises adjacent to the bus parking place;
 - (g) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (h) for the convenience of occupiers of premises adjacent to the bus parking place at times of weddings or funerals or other special occasions.
- (2) A police constable in uniform or a police community support officer may suspend for not longer than 7 days the use of a bus parking place or any part thereof whenever that police constable or police community support officer considers such suspension reasonably necessary for the purpose of preventing or mitigating congestion or obstruction of traffic, or danger to or from traffic, in consequence of extraordinary circumstances.
- (3) Any person suspending the use of a bus parking place or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to that bus parking place or part thereof the use of which is suspended, a traffic sign indicating that waiting by vehicles is prohibited.

(4) Exemptions during suspension of bus parking places

No person shall cause or permit a vehicle to be left in any part of a bus parking place during such period as there is in or adjacent to that part of the bus parking place a traffic sign (indicating that the use of that bus parking place is suspended) placed in pursuance of paragraph (3) of this Article -

Provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for:-

- (a) fire and rescue service, ambulance or police purposes;

- (b) vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
- (c) vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic -

or if the vehicle is left with the permission of the person suspending the use of the bus parking place or part thereof in pursuance of paragraph (1) of this Article, or a person duly authorised by him.

Alteration of Position of Vehicles in Bus Parking Places

- 42. Where a vehicle is standing in a bus parking place in contravention of the provisions of Article 33 or Article 40 of this order a civil enforcement officer, a police constable in uniform or a police community support officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

Removal of Vehicles from Bus Parking Places and Safe Custody of Vehicles

- 43. When a vehicle (other than an immobilisation exempt vehicle) is left in a bus parking place in contravention of any of the provisions of Part IV of this order a civil enforcement officer, a police constable in uniform or a police community support officer may remove or arrange for the removal of the vehicle from that bus parking place, and where it is so removed shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

Method of Removal of Vehicles from Bus Parking Place

- 44. A civil enforcement officer, a police constable in uniform or a police community support officer removing a vehicle by virtue of Article 43 of this order may do so by towing or driving the vehicle, or in such other manner as he may think necessary, and may take such measures in relation to that vehicle as may be thought necessary to enable the removal as aforesaid.

Movement of Vehicles in Bus Parking Place in an Emergency

- 45. Any person generally or specially authorised by the Council, a civil enforcement officer, a police constable in uniform or a police community support officer may cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in a bus parking place.

Placing of Traffic Signs etc.

- 46. The Council shall:-

- (a) place and maintain in or in the vicinity of each bus parking place traffic signs and or carriageway markings of any size, colour and type prescribed or authorised by the Department for Transport indicating that such bus parking place may be used for the purpose of and leaving only of the vehicles specified in Article 29 of this order; and
- (b) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a bus parking place.

PART V

DISABLED PERSONS' PARKING PLACES

Authorisation and Use of Disabled Persons' Parking Places

- 47. Each area of carriageway which is identified as **Disabled badge holders only 8 am – 6 pm 3 hours No return within 1 hour** in the plans (and unless otherwise so indicated on the said plan, bounded on one side of that length by the edge of the carriageway) is hereby authorised to be used, subject to the following provisions of this order, as a parking place for disabled persons' vehicles.
- 48. Each area of carriageway which is identified as **Disabled badge holders only Mon - Fri 9 am - 5 pm 2 hours No return within 4 hours** in the plans (and unless otherwise so indicated on the said plan, bounded on one side of that length by the edge of the carriageway) is hereby authorised to be used between the hours of 9.00 a.m. and 5.00 p.m. on any day other than a Saturday or Sunday, subject to the following provisions of this order, as a parking place for disabled persons' vehicles.
- 49. The driver of a disabled person's vehicle using a disabled persons' parking place identified as **Disabled badge holders only 8 am – 6 pm 3 hours No return within 1 hour** in the plans shall not permit that vehicle to wait in that disabled persons' parking place for a period longer than three hours.
- 50. No disabled person's vehicle which has been taken away from a disabled persons' parking place identified as **Disabled badge holders only 8 am – 6 pm 3 hours No return within 1 hour** in the plans shall again be left in that disabled persons' parking place until the expiration of one hour from the time it was taken away.
- 51. The driver of a disabled person's vehicle using a disabled persons' parking place identified as **Disabled badge holders only Mon - Fri 9 am - 5 pm 2 hours No return within 4 hours** in the plans shall not permit that vehicle to wait in that disabled persons' parking place for a period longer than two hours.
- 52. No disabled person's vehicle which has been taken away from a disabled persons' parking place identified as **Disabled badge holders only Mon - Fri 9 am - 5 pm 2 hours No return within 4 hours** in the plans shall again be left in that disabled persons' parking place until the expiration of four hours from the time it was taken away.
- 53. The limits of each disabled persons' parking place shall be indicated on the carriageway by appropriate traffic signs.

Manner of Standing in Disabled Persons' Parking Places

54. The driver of a disabled person's vehicle waiting in a disabled persons' parking place shall cause it so to stand:-
- (a) if special provisions
in the case of a disabled persons' parking place in relation to which special provisions as to the manner of standing of disabled persons' vehicles in that place are indicated on the carriageway by appropriate traffic signs, so as to be in accordance with those provisions;
 - (b) if no special provisions
in the case of any other disabled persons' parking place on a road in single line parallel to the edge of the carriageway and so that the distance between the edge of the carriageway and the nearest wheel of the disabled person's vehicle is not more than three hundred millimetres; and
 - (c) so that every part of the disabled person's vehicle is wholly within the limits of a disabled persons' parking place.

Restriction of Use of Vehicles at Disabled Persons' Parking Places

55. The driver of a disabled person's vehicle using a disabled persons' parking place shall stop the engine as soon as the vehicle is in position in the disabled persons' parking place and shall not start the engine except when about to change the position of the disabled person's vehicle in, or to depart from, the disabled persons' parking place.
56. The driver of a disabled person's vehicle using a disabled persons' parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the disabled persons' parking place.
57. No person shall use any disabled person's vehicle whilst it is in a disabled persons' parking place for the purposes of or in connection with the sale of or the attempted sale of any article directly from the vehicle to any person in or near the disabled persons' parking place or in connection with the selling or offering for sale of his skill or his services in any other capacity.
58. No person shall use any disabled person's vehicle whilst it is in a disabled persons' parking place to carry out or permit the carrying out of any work of maintenance or repair or the washing down of any disabled person's vehicle except such maintenance or repair as may be necessary to enable the disabled person's vehicle to be moved from the disabled persons' parking place.

Restriction of Waiting in Disabled Persons' Parking Places

59. Save as provided in Article 60 of this order no person shall leave a vehicle in a disabled persons' parking place:-
- (a) unless it is of a class specified in Article 47 or Article 48 of this order; and

- (b) in a position other than that specified in Article 54 of this order.

Restriction of Waiting of Vehicles other than Disabled Persons' Vehicles in Disabled Persons' Parking Places

60. (1) Without prejudice to the foregoing provisions of this order with respect to vehicles which are left in a disabled persons' parking place in accordance with those provisions, any other vehicle not being a disabled person's vehicle may wait anywhere on the carriageway within a disabled persons' parking place (other than a disabled persons' parking place or part thereof the use of which has been suspended) if:-
- (a) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
 - (c) the vehicle is being used for fire and rescue service, ambulance or police purposes or is a vehicle (other than a passenger vehicle) in the service of a local authority being used in pursuance of statutory powers or duties;
 - (d) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
 - (e) the vehicle is to be used by a universal service provider in the course of the provision of a universal postal service for the purpose of delivering or collecting postal packets to or from premises adjacent to the disabled persons' parking place or for the purpose of delivering to or collecting from posting boxes adjacent to that disabled persons' parking place; or
 - (f) the vehicle is waiting only so long as may be reasonably necessary to enable it to be used for the purpose of the maintenance, installation or removal in or adjacent to the disabled persons' parking place of any traffic sign or other street furniture.
- (2) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act of 1984.

Manner of Standing by Exempted Vehicles in Disabled Persons' Parking Places

61. A person causing or permitting a vehicle to wait in a disabled persons' parking place by virtue of the provisions of sub-paragraph (e) and (f) in paragraph (1) of the last preceding Article shall ensure:-

- (a) in the case of a disabled persons' parking place in relation to which special provisions as to the manner of standing of vehicles in that place are indicated on the carriageway by appropriate traffic signs, that the vehicle shall so stand:-
 - (i) unless the length of the vehicle precludes compliance with this sub-paragraph, in accordance with those provisions and so that every part of the vehicle is within the limits of the disabled persons' parking place; or
 - (ii) if the length of the vehicle does preclude compliance with the last preceding sub-paragraph that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than three hundred millimetres; and
- (b) in the case of any other disabled persons' parking place, that the longitudinal axis of the vehicle is parallel to the edge of carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than three hundred millimetres.

Power to Suspend the Use of Disabled Persons' Parking Places

62. (1) Any person generally or specially authorised by the Council may suspend the use of any disabled persons' parking place, or any part thereof, whenever that person considers such suspension reasonably necessary:-
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building, industrial, demolition or excavation operations in or adjacent to the disabled persons' parking place;
 - (c) for the purpose of the maintenance, improvement or reconstruction of the disabled persons' parking place;
 - (d) for the purpose of the laying, erection, alteration, removal or repair in or adjacent to the disabled persons' parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus;
 - (e) for the purpose of the maintenance, installation or removal in or adjacent to the disabled persons' parking place of any traffic sign, bus stop infrastructure or other street furniture;
 - (f) for the convenience of occupiers of premises adjacent to the disabled persons' parking place on any occasion of the removal of furniture or household effects to or from premises adjacent to the disabled persons' parking place;
 - (g) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or

- (h) for the convenience of occupiers of premises adjacent to the disabled persons' parking place at times of weddings or funerals, or on other special occasions.
- (2) A police constable in uniform or a police community support officer may suspend for not longer than 7 days the use of a disabled persons' parking place or any part thereof whenever that police constable or police community support officer considers such suspension reasonably necessary for the purpose of preventing or mitigating congestion or obstruction to traffic, or danger to or from traffic, in consequence of extraordinary circumstances.
- (3) Any person suspending the use of a disabled persons' parking place or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to that disabled persons' parking place or part thereof the use of which is suspended, a traffic sign indicating that waiting by vehicles is prohibited.

(4) Exemptions during suspension of disabled persons' parking places

No person shall cause or permit a vehicle to be left in any part of a disabled persons' parking place during such period as there is in or adjacent to that part of the disabled persons' parking place a traffic sign (indicating that the use of that disabled person's parking place is suspended) placed in pursuance of paragraph (3) of this Article -

Provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for:-

- (a) fire and rescue service, ambulance or police purposes;
- (b) vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident; or
- (c) vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic -

or if the vehicle is left with the permission of the person suspending the use of the disabled persons' parking place or part thereof in pursuance of paragraph (1) of this Article, or a person duly authorised by him.

Alteration of Position of Vehicles in Disabled Persons' Parking Places

63. Where a vehicle is standing in a disabled persons' parking place in contravention of the provisions of Article 54 or Article 61 of this order a civil enforcement officer, a police constable in uniform or a police community support officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

Removal of Vehicles from Disabled Persons' Parking Places and Safe Custody of Vehicles

64. When a vehicle (other than an immobilisation exempt vehicle) is left in a disabled persons' parking place in contravention of any of the provisions of Part V of this order a civil enforcement officer, a police constable in uniform or a police community support officer may remove or arrange for the removal of the vehicle from that disabled persons' parking place, and where it is so removed shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

Method of Removal of Vehicles from Disabled Persons' Parking Places

65. A civil enforcement officer, a police constable in uniform or a police community support officer removing a vehicle by virtue of Article 63 of this order may do so by towing or driving the vehicle, or in such other manner as he may think necessary, and may take such measures in relation to that vehicle as may be thought necessary to enable the removal as aforesaid.

Movement of Vehicles in Disabled Persons' Parking Places in an Emergency

66. Any person generally or specially authorised by the Council, a civil enforcement officer, a police constable in uniform or a police community support officer may cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in a disabled persons' parking place.

Placing of Traffic Signs etc.

67. The Council shall:-
- (a) place and maintain in or in the vicinity of each disabled persons' parking place traffic signs and or carriageway markings of any size, colour and type prescribed or authorised by the Department for Transport indicating that such disabled persons' parking place may be used for the purpose of and leaving only of the vehicles specified in Article 47 and Article 48 of this order; and
 - (b) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a disabled persons' parking place.

PART VI **CAR CLUB PARKING PLACES**

Designation and Use of Car Club parking places

68. Each area of carriageway which is identified as **Car club permit holders only** in the plans (and unless otherwise so specified on the said plans, bounded on one side of that length by the edge of the carriageway) is hereby designated to be used, subject to the following provisions of this order, as a Car Club parking place for Car Club vehicles.

Number and Situation of Car Club Parking Bays

69. The number and situation of parking bays in each Car Club parking place shall be as determined by the Council.
70. The limits of each Car Club parking place and of each Car Club parking bay shall be indicated on the carriageway by appropriate traffic signs.

Manner of Standing in Car Club Parking Places

71. The driver of a Car Club vehicle waiting in a Car Club parking place shall cause it so to stand:-
 - (a) if special provisions

in the case of a Car Club parking place in relation to which special provisions as to the manner of standing of a vehicle in that place are indicated on the carriageway by appropriate traffic signs, as to be in accordance with those provisions;
 - (b) if no special provisions

on a road in a single line parallel to the edge of the carriageway and so that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than three hundred millimetres; and

so that every part of the vehicle is wholly within the limits of a single Car Club parking bay.

Restriction of Use of Vehicles at Car Club Parking Places

72. The driver of a vehicle using a Car Club parking place shall stop the engine as soon as the vehicle is in position in the Car Club parking place and shall not start the engine except when about to change the position of the vehicle in, or to depart from, the Car Club parking place.
73. The driver of a vehicle using a Car Club parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the Car Club parking place.
74. No person shall use any vehicle whilst it is in a Car Club parking place in connection with the sale of or the attempted sale of any Article to any person in or near the Car Club parking place or in connection with the selling or offering for hire his skill or his services in any other capacity.
75. No person shall use any vehicle whilst it is in a Car Club parking place to carry out or permit the carrying out of any work of maintenance or repair or the washing down of any vehicle except such maintenance or repair as may be necessary to enable the vehicle to be moved from the Car Club parking place.

Restriction of Waiting in Car Club Parking Places

76. Save as provided in Article 77 of this order no person shall leave a vehicle in a Car Club parking place:-
- (a) unless it is a Car Club vehicle; and
 - (b) in a position other than that specified in Article 71 of this order.

Restriction of Waiting of Vehicles other than Car Club Vehicles in Car Club Parking Places

77. (1) Without prejudice to the foregoing provisions of this order with respect to vehicles which are left in a Car Club parking place in accordance with those provisions, a vehicle not being a Car Club vehicle may wait anywhere on the carriageway within a Car Club parking place (other than a Car Club parking place or part thereof the use of which has been suspended), if:-
- (a) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
 - (c) the vehicle is being used for fire and rescue service, ambulance or police purposes or is a vehicle (other than a passenger vehicle) in the service of a local authority being used in pursuance of statutory powers or duties;
 - (d) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
 - (e) the vehicle is to be used by a universal service provider in the course of the provision of a universal postal service for the purpose of delivering or collecting postal packets to or from premises adjacent to the Car Club parking place or for the purpose of delivering to or collecting from posting boxes adjacent to that Car Club parking place; or
 - (f) the vehicle is waiting only so long as may be reasonably necessary to enable it to be used for the purpose of maintenance, installation or removal in or adjacent to the Car Club parking place of any traffic sign, bus stop infrastructure or other street furniture.
- (2) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under section 25 of the Act of 1984.

Manner of Standing by Exempted Vehicles in Car Club Parking Places

78. A person causing or permitting a vehicle to wait in a Car Club parking place by virtue of the provisions of sub-paragraph (e) or (f) of the last preceding Article shall ensure -

- (a) in the case of a Car Club parking place in relation to which special provisions as to the manner of standing of vehicles in that place are indicated on the carriageway by appropriate traffic signs so that the vehicle shall so stand -
 - (i) unless the length of the vehicle precludes compliance with this sub-paragraph, in accordance with those provisions and so that every part of the vehicle is within the limits of the Car Club parking place, or
 - (ii) if the length of the vehicle does preclude compliance with the last preceding sub-paragraph that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than three hundred millimetres; and
- (b) in the case of any other Car Club parking place so that every part of the vehicle is within the limits of a parking bay and the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and nearest wheel of the vehicle is not more than three hundred millimetres.

Power to Suspend Use of Car Club Parking Places

79. (1) Any person generally or specially authorised by the Council may suspend the use of a Car Club parking place, or any part thereof, whenever that person considers such suspension reasonably necessary:-
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building, industrial, demolition or excavation operations in or adjacent to the Car Club parking place;
 - (c) for the purpose of the maintenance, improvement or reconstruction of the Car Club parking place;
 - (d) for the purpose of the laying, erection, alteration, removal or repair in or adjacent to the Car Club parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus;
 - (e) for the purpose of the maintenance, installation or removal in or adjacent to the Car Club parking place of any traffic sign, bus stop infrastructure or other street furniture;
 - (f) for the convenience of occupiers of premises adjacent to the Car Club parking place on any occasion of the removal of furniture or household effects to or from premises adjacent to the Car Club parking place;

- (g) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (h) for the convenience of occupiers of premises adjacent to the Car Club parking place at times of weddings or funerals, or on other special occasions.
- (2) A police constable in uniform or a police community support officer may suspend for not longer than 7 days the use of a Car Club parking place or any part thereof whenever that police constable or police community support officer considers such suspension reasonably necessary for the purpose of preventing or mitigating congestion or obstruction of traffic, or danger to or from traffic, in consequence of extraordinary circumstances.
- (3) Any person suspending the use of a Car Club parking place or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to that Car Club parking place or any part thereof the use of which is suspended, a traffic sign indicating that the waiting by vehicles is prohibited.
- (4) Exemptions during Car Club parking place suspension

No person shall cause or permit a vehicle to be left in any part of a Car Club parking place during such period as there is in or adjacent to that part of the Car Club parking place a traffic sign (indicating that the use of that Car Club parking place is suspended) placed in pursuance of paragraph (3) of this Article -

Provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for:-

- (a) fire and rescue service, ambulance or police purposes;
- (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
- (c) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic -

or if that vehicle is left with the permission of the person suspending the use of the Car Club parking place or the part thereof in pursuance of paragraph (1) of this Article or a person duly authorised by him.

Alteration of Position of Vehicle in Car Club Parking Places

80. Where any vehicle is standing in a Car Club parking place in contravention of the provisions of Article 71 or Article 78 of this order a civil enforcement officer, a police constable in uniform or a police community support officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

Removal of Vehicle from Car Club Parking Places and Safe Custody of Vehicle

81. When a vehicle, other than an immobilisation exempt vehicle, is left in a Car Club parking place in contravention of any of the provisions of Part VI of this order a civil enforcement officer, police constable in uniform or a police community support officer may remove or arrange for the removal of the vehicle from that Car Club parking place and, where it is so removed shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

Method of Removal of Vehicles from Car Club Parking Places

82. Any person removing or altering the position of a vehicle by virtue of Article 80 or Article 81 of this order may do so by towing or driving the vehicle, or in such other manner as he may think necessary and may take such measures in relation to the vehicle as may be thought necessary to enable the removal as aforesaid.

Movement of Vehicles in Car Club Parking Places in an Emergency

83. Any person generally or specially authorised by the Council, a civil enforcement officer, a police constable in uniform or a police community support officer may cause to be moved, in case of emergency, to any place he thinks fit, any vehicle left in a Car Club parking place.

Placing of Traffic Signs etc

84. The Council shall:-
- (a) place and maintain in or in the vicinity of each Car Club parking place traffic signs and or carriageway markings of any size, colour and type prescribed or authorised by the Department for Transport indicating that such disabled persons' parking place may be used for the purpose of and leaving only of the vehicles specified in Article 68 of this order; and
 - (b) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a Car Club parking place.

PART VII **E-SCOOTER AND CYCLE HIRE PARKING PLACES**

Authorisation and Use of E-scooter and Cycle Hire Parking Places

85. Each area of carriageway which is identified as **E-scooter & cycle hire only** in the plans (and unless otherwise so specified on the said plans, bounded on one side of that length by the edge of the carriageway) is hereby authorised to be used, subject to the following provisions of this order, as a parking place for electric scooters and electrically assisted pedal cycles.

Vehicles for which E-scooter and Cycle Hire Parking Places are Authorised

86. Each e-scooter and cycle hire parking place may be used, subject to the provisions of this order, for the leaving of electric scooters or electrically assisted pedal cycles by a person who has paid any relevant hire charge or other charge to any person or organisation acting on behalf of the Council approved in writing by the Council, and which has been hired by means of a real-time or advance booking system authorising the use of the vehicle for a specified period.

Number and Situation of E-scooter and Cycle Hire Parking Places

87. The limits of each e-scooter and cycle hire parking place shall be indicated by the Council on the highway by appropriate traffic signs.

Manner of Standing in E-scooter and Cycle Hire Parking Places

88. Every electric scooter and electrically assisted pedal cycle left in an e-scooter and cycle hire parking place shall so stand so that every part of the electric scooter or electrically assisted pedal cycle shall be wholly within the limits of the e-scooter and cycle hire parking place.

Restriction of Use of Vehicles at E-scooter and Cycle Hire Parking Places

89. The rider of an electric scooter or electrically assisted pedal cycle using an e-scooter and cycle hire parking place shall not sound any horn, bell or other similar instrument except when about to change the position of the electric scooter or electrically assisted pedal cycle in, or to depart from, the e-scooter and cycle hire parking place.
90. No person shall use an electric scooter or electrically assisted pedal cycle while it is in an e-scooter and cycle hire parking place in connection with the sale of or the attempted sale of any article to any persons in or near the e-scooter and cycle hire parking place or in connection with the selling or offering for hire of his skill or services in any other capacity.

Restriction of Waiting in E-scooter and Cycle Hire Parking Places

91. Save as provided in Article 92 of this order no person shall leave a vehicle in an e-scooter and cycle hire parking place:
- (a) unless it is an electric scooter or electrically assisted pedal cycle of a class as prescribed in Article 85 of this order; and
 - (b) in a position other than that specified in Article 88 of this order.

Restriction of Waiting of Vehicles other than Electric Scooters and Electrically assisted pedal cycles in E-scooter and Cycle Hire Parking Places

92. (1) Without prejudice to the foregoing provisions of this order with respect to vehicles which are left in an e-scooter and cycle hire parking place in accordance with those provisions, any vehicle not being an electric scooter or electrically assisted pedal cycle may wait anywhere on the highway within an e-scooter and cycle hire parking place (other than an e-scooter and cycle hire parking place or part thereof the use of which has been suspended), if:-
- (a) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
 - (c) the vehicle is being used for fire and rescue authority, ambulance or police purposes or is a vehicle (other than a passenger vehicle) in the service of a local authority being used in pursuance of statutory powers or duties;
 - (d) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic;
 - (e) the vehicle is to be used by a universal service provider in the course of the provision of a universal postal service for the purpose of delivering or collecting postal packets to or from premises adjacent to the e-scooter and cycle hire parking place or for the purpose of delivering to or collecting from posting boxes adjacent to that e-scooter and cycle hire parking place; or
 - (f) the vehicle is waiting only so long as may be reasonably necessary to enable it to be used for the purpose of the maintenance, installation or removal in or adjacent to the e-scooter and cycle hire parking place of any traffic sign, bus stop infrastructure or other street furniture.
- (2) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act of 1984.

Manner of Standing by Exempted Vehicles in E-scooter and Cycle Hire Parking Places

93. A person causing or permitting a vehicle to wait in an e-scooter and cycle hire parking place by virtue of the provisions of sub-paragraph (e) and (f) in paragraph (1) of the last preceding Article shall ensure -

- (a) in the case of an e-scooter and cycle hire parking place in relation to which special provisions as to the manner of standing of vehicles in that place are indicated on the carriageway by appropriate traffic signs, that the vehicle shall so stand -
 - (i) unless the length of the vehicle precludes compliance with this sub-paragraph, in accordance with those provisions and so that every part of the vehicle is within the limits of the e-scooter and cycle hire parking place, or
 - (ii) if the length of the vehicle does preclude compliance with the last preceding sub-paragraph that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than three hundred millimetres; and
- (b) in the case of any other e-scooter and cycle hire parking place, that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and nearest wheel of the vehicle is not more than three hundred millimetres.

Power to Suspend Use of E-scooter and Cycle Hire Parking Places

94. (1) Any person generally or specially authorised by the Council may suspend the use of any e-scooter and cycle hire parking place, or any part thereof, whenever that person considers such suspension reasonably necessary:—
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building, industrial, demolition or excavation operations in or adjacent to the e-scooter and cycle hire parking place;
 - (c) for the purpose of the maintenance, improvement or reconstruction of the e-scooter and cycle hire parking place;
 - (d) for the purpose of the laying, erection, alteration, removal or repair in or adjacent to the e-scooter and cycle hire parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any electronic communications apparatus;

- (2) A police constable in uniform or a police community support officer may suspend for not longer than 7 days the use of an e-scooter and cycle hire parking place or any part thereof whenever that police constable or police community support officer considers such suspension reasonably necessary for the purpose of preventing or mitigating congestion or obstruction of traffic, or danger to or from traffic, in consequence of extraordinary circumstances.
- (3) Any person suspending the use of an e-scooter and cycle hire parking place or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to that e-scooter and cycle hire parking place or part thereof the use of which is suspended, a traffic sign indicating that waiting by vehicles is prohibited.
- (4) Exemptions During E-scooter and Cycle Hire Parking Places Suspension

No person shall cause or permit a vehicle to be left in any part of an e-scooter and cycle hire parking place during such period as there is in or adjacent to that part of the e-scooter and cycle hire parking place a traffic sign (indicating that the use of that e-scooter and cycle hire parking place is suspended) placed in pursuance of paragraph (3) of this Article –

Provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for:-

- (a) fire and rescue authority, ambulance or police purposes;
- (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary to avoid an accident;
- (c) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic -

or if the vehicle is left with the permission of the person suspending the use of the e-scooter and cycle hire parking place or part thereof in pursuance of paragraph (1) of this Article, or a person duly authorised by him.

Alteration of Position of Electric Scooters and Electrically Assisted Pedal Cycles in E-scooter and Cycle Hire Parking Places

95. Where an electric scooter or electrically assisted pedal cycle is standing in an e-scooter and cycle hire parking place in contravention of the provisions of Article 88 of this order or a vehicle is standing in an e-scooter and cycle hire parking place in contravention of the provision of Article 93 of this order a civil enforcement officer or police community support officer or a police constable in uniform may alter or cause to be altered the position of that electric scooter or electrically assisted pedal cycle or that vehicle in order that its position shall comply with those provisions.

Removal of Vehicles from E-scooter and Cycle Hire Parking Places and Safe Custody of Vehicles

96. When a vehicle, other than an immobilisation exempt vehicle, is left in an e-scooter and cycle hire parking place in contravention of any of the provisions of Part VII of this order, a civil enforcement officer, or a police community support officer or a police constable in uniform may remove or arrange for the removal of the vehicle from that e-scooter and cycle hire parking place, and where it is so removed shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

Method of Removal of Vehicles from E-scooter and Cycle Hire Parking Places

97. A civil enforcement officer, a police constable in uniform or a police community support officer removing a vehicle by virtue of Article 96 of this order may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as may be thought necessary to enable the removal as aforesaid.

Movement of Electric Scooters and Electrically Assisted Pedal Cycles in E-scooter and Cycle Hire Parking Places in Emergencies

98. Any person generally or specially authorised by the Council, a civil enforcement officer, a police constable in uniform, or a police community support officer may move or cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in an e-scooter and cycle hire parking place.

Placing of Traffic Signs etc.

99. The Council shall:-
- (a) place and maintain in or in the vicinity of each e-scooter and cycle hire parking place traffic signs and or highway markings of any size, colour and type prescribed or authorised by the Department for Transport indicating that such e-scooter and cycle hire parking place may be used and for the leaving only, of the vehicles specified in Article 85 of this order; and
 - (b) carry out such other work as is reasonably required for the purposes of the satisfactory operation of an e-scooter and cycle hire parking place.

PART VII
REVOCATION OF ORDER

100. The City Council of Bristol (Various Roads, St. George Area, Lawrence Hill, Easton, St. George Central, St. George Troopers Hill and St. George West Wards, City of Bristol) (Prohibition and Restriction of Waiting) (Prohibition of Stopping) (Loading Places) (Bus Parking Places) (Disabled Persons' Parking Places) (Car Club Parking Places) Order 2026 is hereby revoked.
101. The provisions of this order shall be in addition to and not in derogation from the provisions of any regulations made or having effect as if made under the Act of 1984 or by any other enactment.
