# Licensing Act 2003 Fees and Charges

Fees for all Licensing Act 2003 permissions have been set by the Department of Culture, Media and Sport.

The fees are based on the non-domestic rateable value of the premises. You can find out the non-domestic rateable value of your premises by entering your postcode into the Valuation Office's website at <a href="https://www.voa.gov.uk">www.voa.gov.uk</a>.

#### The values are divided into five bands

## **Grant or variation applications**

The application fees for the grant or variation of premises licences and club premises certificates are listed in the next table. There will be a multiplier applied to premises in Bands D ( X 2 the basic fee) and E ( X3 the basic fee) where they are exclusively or primarily in the business of supplying alcohol.

Exceptionally large events of a temporary nature that require premises licences will be charged an additional fee on top of the premises licence fee as follows:

# **Provisional applications**

Premises under construction that have not been allocated a non-domestic rateable value will be given such a value as soon as the completion certificate is provided. In these cases such premises are allocated to Band C. Subsequent annual fees will relate to the non-domestic rateable value given to the property.

# **Exempt premises**

Premises licences sought for community centres and some schools that permit regulated entertainment but do not permit the supply of alcohol and/or the provision of late night refreshment will not incur a fee.
