The neighbourhood partnerships are an opportunity for local people to influence the local infrastructure. The capital schemes which are recommended by local people are prioritised if they solve local problems, such as residential roads being used as rat runs by commuters, and problems with parking, speeding etc. It is likely that a proportion of these schemes highlighted as important for people with protected characteristics such as schemes around schools or easier routes/dropped kerbs for people using electric scooters etc. Schemes have also been implemented by NPs which improve community cohesion by relieving parking pressures. It is hard to quantify whether local schemes in reality benefit people with protected characteristics more or less than traffic management measures which are prioritised by city council officers. However the removal of this funding would remove the opportunity for local people to affect a local traffic arrangement and the community would feel that this would disadvantage people with protected characteristics because there is less opportunity to request a change. Therefore whilst hard to prove, it is likely that older people, younger people, BME people, women and disabled people would feel disadvantaged by a decision to remove
