The Loco Klub is a joint venture with The Invisible Circus; at our core we aim to be a collaborative, cultural hub for a creative

city, celebrating community, diversity and the power of the arts.

We are a multi-use events space below Temple Meads station, inhabiting 'Brunel' built ash pit tunnels where we host a

variety of different shows: theatre, gigs, club nights, private parties, poetry readings, drag nights, cabarets, exhibitions and

more. These are but a few of the different types of nights we currently programme and support here.

In this variation, we would like to have our current licensable activities to be able to be carried out until 3am on Fridays and Saturdays.

This would remove the existing limit we are under at this time, whereby we are granted to have only up to five extensions

of licensable activity a month from 1:30am to 3am.

Presently, we have been having to add to this limit in our busier months through the use of Temporary Event Notices,

though this will not be enough to cover us throughout the rest of 2024.

We would also like the option of having an extension of licensable activity till 4am up to three times a month on Friday and

Saturday nights.

This would allow us to host these types of nights consistently throughout the year, which currently isn't possible due to the

restrictions of our licence and the amount of TENs we are allocated a year.

In addition to this change we would like to increase our maximum capacity to 426.

This is coming off of a recent Fire Risk

Assessment conducted that states we can have this amount of people in the venue safely. This FRA will be attached as a

supporting document to this application.
