Introduction

The new EHC Needs Assessment Contributions form should be completed on Bristol City Council's Professional Portal. The purpose of this form is to capture contributions to a child/young person's statutory Education, Health and Care (EHC) Needs Assessment.

The Professional Portal is for 'external' professionals such as Educational settings, Health and other independent organisations/individuals.

It allows professionals to fill in 'forms' relating to children/young people they are working with and submit them securely to Bristol City Council's case management system, Liquidlogic. Submitted forms can then be viewed (as read only) by the relevant team/s, for example SEND.

This guidance is designed to support therapists to fill in the EHC Needs Assessment Contributions form on the portal, managers to moderate and Admin who triage and submit these forms to SEND.

For general guidance on using the Professional Portal (for example registering, logging in/out, how to get support), please follow the guidance called **Using the Professional Portal – Guidance for Professionals**.

Important: Anything you enter in the contribution form will be shared with the young person/parents/carers and other professionals involved with the young person. It will appear in the EHCP (if there is a decision to issue). Please consider this when writing your contribution.

Receiving and triaging the EHC Needs Assessment Contributions form (Admin)

When Bristol's SEND team are requesting an EHC Needs Assessment Contribution from Occupational Therapy/Physiotherapy, they will delegate the form to the **OT & Physio EHC Contributions** group on the Professional Portal.

All Admin staff, therapists and managers have access to pickup, reassign, complete and submit forms sent from this group. However it is Admin who will triage the forms and send them to the relevant therapist for completion. Admin will also be responsible for submitting the forms back to SEND once the therapists have filled in the details (and managers have moderated).

1. When a form is assigned to the group, an email will be sent to the <u>sirona.otpt-ehcp@nhs.net</u> email address which will be monitored by Admin:







The form will disappear from your list of tasks and will be reassigned to the therapist:

Professional Portal - tasks to complete



The therapist will receive an email to notify them that there's a form assigned to them for completion. Once they have filled in the form, and managers have moderated the contribution, the form will be reassigned back to the group, at which point it can be picked back up by Admin and submitted, see <u>Submitting the contribution to SEND and downloading a copy</u> (Admin).

Note: if you have reviewed the child/young person's details and found they are 'not known to service' and therefore a contribution cannot be completed, leave the form uncompleted in the portal and contact the Bristol SEND team. They will need to 'retract' the form from you so that it disappears from the portal.

Filling in the EHC Needs Assessment Contributions form (Occupational Therapist/Physiotherapist)

It is the OT and/or Physiotherapists' responsibility to fill in the EHC Needs Assessment Contributions form on the portal. This section explains how to access and fill in the form on the Professional Portal and assign it to a manager for moderation. Following this, the form will be submitted to SEND by Admin.

Note: As this form is a joint form between Occupational Therapy and Physiotherapy, if both services need to contribute then therapists can either work on the form together (e.g. sharing computer screens) or reassign the form between them on the portal in order to complete a joint contribution.

As you work through the form you can **Save** and **Close** at any time using the buttons at the bottom of the page. Once saved the form can be accessed again any time from your


Specific Provision (Section F) and additional 'Specific Strategies'

- 1. If you have identified any Specific Provision (F), fill out the details in the table provided recording one provision per row on the table:
 - **Specific Provision**: in this column you should provide a concise description of the provision that will be put in place/is in place
 - How often: in this column you should record the length, frequency and duration of
 the provision if possible e.g. 20 mins, weekly, for 6 weeks. This is important
 because it makes it clear to families exactly what provision they will receive and
 ensures provision is specific and quantifiable. It also makes it much easier to
 deliver and review the EHCP if there is one issued.
 - **Group size:** e.g. 1:1, group of up to 20 etc. if applicable
 - By whom: the person or professional role who will deliver the provision
 - Is the provision above core service?: Yes/No
 - Which SEN Category will this provision meet?: select the SEN categories identified which this provision will meet. It is essential that any need categories

Moderating the EHC Needs Assessment Contribution form (OT/Physio Manager)

Managers are responsible for reviewing and moderating forms completed by OT/Physios, signing off the form and then reassigning to the OT & Physio EHC **Contributions** group. Admin will then download a copy of the form and submit it to SEND.


Making amendments and assigning to Admin following moderation (OT/Physio)

Once the manager has reviewed the contribution, they will assign it back to the OT/Physio on the Professional Portal. You will receive an email as before to say that a form has been assigned to you.


You may be required by the manager/s to make some changes to your contribution, in which case you will need to click on the form and update it.

Once the form is ready to be submitted, you need to assign it back to the Group where Admin can pick it up and submit it:

1. Click Reassign:



Click Select Group to reassign the form to the OT & Physio EHC Contributions group tray:



Following this, Admin will pick up the form, download a copy for internal records, and submit the form to SEND.




Submitting the contribution to SEND and downloading a copy (Admin)

Once the contribution form has been completed by therapists and moderated by managers, the task will be assigned back to the group tray. Another email will be sent to the sirona.otpt-ehcp@nhs.net email address. From here Admin will need to pickup and submit the form to SEND and download a copy of the contribution for internal records:

1. Click **Pickup** to open the form:



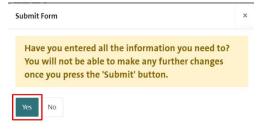
2. Navigate to the second tab of the form and enter the date you are submitting it in the field provided:





Picking up and Reassigning forms between Therapists (Admin)

There may be scenarios where Admin need to reassign a contribution form from one therapist to another e.g. if the therapist is off sick/on leave, or they have asked you to assign the form to another colleague for completion. Please do not do this unless agreed by the therapist/manager so as not to cause confusion (as soon as you reassign the task it will be removed from their list of tasks).

If you need to pick up and/or reassign a task that is currently assigned to another individual in your group, navigate to **Group member tasks:**
