

## CITY COUNCIL OF BRISTOL

### (VARIOUS ROADS, OUTER SOUTH AREA – BISHOPSWORTH, BRISLINGTON EAST, BRISLINGTON WEST, HARTCLIFFE & WITHYWOOD, HENGROVE & WHITCHURCH PARK AND STOCKWOOD WARDS, CITY OF BRISTOL) (DE-RESTRICTION) (20 MPH SPEED LIMIT) (40 MPH SPEED LIMIT) (VARIATION NO. 1) ORDER 202-

The City Council of Bristol (hereinafter referred to as “the Council”) in exercise of its powers under sections 82(2), 83(2), 84(1) and (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following order:-

#### Variation of Order

1. The City Council of Bristol (Various Roads, Outer South Area - Bishopsworth, Brislington East, Brislington West, Hartcliffe & Withywood, Hengrove & Whitchurch Park and Stockwood Wards, City of Bristol) (De-Restriction) (20 Mph Speed Limit) (40 Mph Speed Limit) Order 2021 is hereby varied and shall have effect as though:-
  - (a) in the Schedule thereto there were substituted for the plan number TRO-19-026P-00 therein the following plan number, namely TRO-19-026P-00-RevA;
  - (b) in the Schedule thereto there were substituted for the plan number TRO-19-026P-04 therein the following plan number, namely TRO-19-026P-04-RevA;
  - (c) in the Schedule thereto there were substituted for the plan number TRO-19-026P-06 therein the following plan number, namely TRO-19-026P-06-RevA; and
  - (d) there were substituted for plans numbered TRO-19-026P-00, TRO-19-026P-04 and TRO-19-026P-06 annexed thereto the following plans as annexed to this order, namely - TRO-19-026P-00-RevA, TRO-19-026P-04-RevA and TRO-19-026P-06-RevA.

#### Revocation of Order

2. The City Council of Bristol (Various Roads (Jessop Park Development), Hengrove & Whitchurch Park Ward, City of Bristol) (De-Restriction) (20 Mph Speed Limit) Order 2022 is hereby revoked.
